READ THE RULES BELOW PRIOR TO COMPLETING THE ENTRY FORMS

Eligibility: The Exhibition is open to paid PSL Arts League members only.

Four Categories: Oil, Acrylic, Watercolor and Various Mediums - including, but not limited to: *Pastel, Pencil, Ink, Print Making, Digital Art, Jewelry, Fiber, Photography, 3D.*

Up to 3 artworks may be submitted. Any 2D art more than 40" in height or width, including frame, will count as 2 entries. In the event the number of entries exceeds the available gallery space, only the first two artworks entered will be accepted.

RULES

To Enter: Review all PSLAL and MIDFLORIDA Event Center registration rules prior to completing your entry form. Complete the MIDFLORIDA Event Center Exhibition Contract and Image list; include a photo of each artwork, title, dimensions, medium, sale price (or NFS), and insurance value for each entry and email to: pslal.djacoby@yahoo.com. with the subject line Member Show Registration, or mail to Doris Jacoby at 251 Travis Cay Pl., Fort Pierce FL 34982

Entries must be received by December 1, 2020 to meet the Civic Center's commitment to their insurance carrier and legal dept. By submitting the entry form, all artists are agreeing to adhere to the rules established by the MIDFLORIDA Event Center and PSLAL.

Original art only: No giclées or reproductions of any kind will be accepted.

Artwork **must not have been** shown in the Event Center Gallery prior to this exhibit. Artwork is to remain on exhibit from **February 1, 2021 through March 26, 2021.**

No substitutions: Only artwork listed on the artist Image List will be accepted at drop off. NO CHANGES MAY BE MADE AFTER JAN. 4, 2021.

The artist is responsible for: transporting, delivery and removal of artwork on the dates noted above **and** compliance with all applicable Federal, State and City laws and regulations, including sales tax.

Presentation:

- 2D artwork must be appropriately framed or on gallery wrapped artist canvas at least 1.25 inch in depth with professionally finished sides and no visible staples. Matted work must have glass or plexiglass.
- All work must be in "New" condition; Damaged work or dirty glass or frames, etc., will not be accepted.
- All 2D Artwork must be properly wired for hanging (no razor hangers).
- **Labels:** All artwork must be labeled prior to drop-off using labels provided to you on receipt of your entry.

PSLAL reserves the right to reject entries deemed inappropriate or unprofessionally presented.
